- Automatic Delivery – deliveries will be automatically scheduled by Central Gas & Appliance, Inc.
- Will Call – I will contact Central Gas & Appliance, Inc. when I require a delivery Special Terms and Conditions Apply. Central Gas & Appliance, Inc. is not responsible for run outs.

Payment Type:

- Regular – Payments are due within 30 days of invoice. After 30 days, a late charge will be assessed on unpaid balances at 1.5% per month (18% annually.) If the account goes 90 days past due, service will be disconnected and your account will be turned over to a collection agency. You agree to pay any collection fees and cost related to collection of past due balances herein. If the account goes to collections status and you wish to continue services after the account has been paid, any future account activity will be paid in advance or at the time of delivery of goods or services.
- Budget - A payment plan will be established based on historical or projected usage and you pay equal payments for 11 months. On the 12th month, we will settle any outstanding balance by invoice to you or credits can be applied to the following year's budget. Budgets restart in May each year.
- COD – Pay in advance to have a delivery while we are in your area. We encourage you to pay in advance through regular payments or automatic card billing to build a credit balance on the account.

I (We) certify that all information listed above is correct and current. I (We) authorize Central Gas & Appliance, Inc. to conduct a credit check to determine my credit worthiness and ability to pay for services ordered. I understand that based on a review of my credit rating, a security deposit may be required. Failure to establish credit worthiness will result in the applicant being required to post a security deposit or payment in advance of services rendered.

Central Gas & Appliance, Inc. may report performance under any agreement Customer may enter into with Central Gas & Appliance, Inc. to any credit agency. Further terms and conditions governing the supply of propane, equipment and service to Customer are contained in the customer contract which must also be signed to obtain service.
